

## **HOF Inductee Nominations**

During the fall meeting, the Board normally selects the Hall of Fame Inductees, if there are to be any. This year the Board would like to hear from the members if they have any nominees. Listed below are criteria for selection. For more information, please see the LTA by-laws posted on the website.

### **Criteria:**

A living person must have more than ten (10) years involvement in trapshooting. There is no time requirement for posthumous induction into the HOF.

The person must have significant honors and accomplishments because of his or her shooting abilities.

The person must be recognized as one who has helped promote and enhance trapshooting in Louisiana.

### **Significant Accomplishments May Be Any Of The Below:**

Person must have earned a significant number of Louisiana state shoot championship awards.

Person must have earned out-of-state, zone, and/or Grand American championship awards.

Person must have qualified for Louisiana state team and/or the All American team.

Person must have a significant number (greater than 100,000) of lifetime targets to his/her credit.

### **Significant Contributions to the Trapshooting Sport**

Person must have recognized service to the LTA and/or ATA; or

Must have held offices in the LTA and/or ATA; or

Must have given significant amounts of time and/or funding in support of Louisiana gun clubs; or

Must have given significant amounts of time in helping others improve their talent and skills at trapshooting.

In addition, the person must be a respected individual who has exhibited a cooperative spirit when involved in the sport.

### **Nomination Process**

The board has access to the lifetime targets attained and the major awards received by an individual, therefore it is not necessary to furnish this information other to know that such accomplishments exist.

It will be necessary for the individual making the nomination to include as much information about the nominee's significant contributions to the trapshooting sport as is known. This input will play a major role in the final selection process.

Compile the list of significant contributions and e-mail this information to Jim Jenkins, LTA Secretary/Treasurer, at [jsjenkins@att.net](mailto:jsjenkins@att.net) . This information must be received by mid-August in order to be considered by the Board at the fall meeting.

## Application for LTA Board Membership

Board members must be willing and able to support the LTA activities including the State Shoot by contributing time and effort in preparing for the shoot as well as expending efforts during the weekend of the State Shoot. Ongoing efforts include selling sponsorship advertisements that are printed in the program booklet, ordering trophies and other awards presented at the State Shoot, and participating in other fund raising events such as selling raffle tickets for drawings held at the State Shoot. Board members assure that the State Shoot is a success, and must be willing to do the work in order to make it so.

Board members must attend one to two meetings during the year as a part of the State Shoot planning process, usually held in a central location such as Alexandria. Board members must be willing to contribute their time as well as their travel expenses as they may occur.

Board members are always looking for individuals to be on the board who want to help enhance the trapshooting sport.
